 31 **Item No.1 - Conditional Use Home Business:** The Providence City Administrative Land Use  
 32 Authority will consider for approval an amendment to the business plan for Gigi's Grooming located at  
 33 230 W 500 S, Providence UT.

 35 • Skarlet Bankhead called item 1, gave a brief introduction and asked Diane Campbell to give an  
 36 overview of the request.  
 37 • Diane Campbell indicated that this item or conditional use was before the ALUA at the last  
 38 meeting and that the staff report is essentially the same but with a business plan amendment  
 39 which was received on October 31st, 2023.  
 40 • Skarlet Bankhead asked Evelyn Rust, applicant, to the table to discuss her amendments.  
 41 • Mrs. Rust indicated that she is amending her business plan as she has invited her friend, Kim  
 42 Niveson, to come work in her shop. Mrs. Niveson will be running Tiny Dawg Grooming, which  
 43 will work out of Mrs. Rust's home. Mrs. Niveson will be renting booth space from Mrs. Rust;  
 44 Mrs. Niveson will also be getting her own business license. Mrs. Rust commented that they will  
 45 now be expecting 24 appointments per week rather than the 15 appointments that were  
 46 previously approved for.

- 47 • Parties discussed the possibility of increased traffic due to more appointments and how many  
48 days each groomer will work. ALUA cautioned Mrs. Rust of the noise and nuisance ordinance  
49 the city has as it sounds like there will be an increase in dogs being groomed. Also reminded her  
50 to make sure dogs are on leashes when outside. Mrs. Rust responded that they shouldn't have  
51 more than 4 dogs at a time.
- 52 • ALUA clarified that that conditional use applications run with the property. Mrs. Rust indicated  
53 Mrs. Niveson's Tiny Dawg Grooming business would be incorporated into her business and be  
54 located at her home, so Mrs. Niveson does not need to go through the conditional use process.
- 55 • No further comments or questions.
