Item No.1 - Conditional Use Home Business: The Providence City Administrative Land Use Authority will consider for approval a request by Makiah Luther for an in-home salon located at 555 S 75 W, Providence UT. [APPLICATION INFORMATION](#)

- The Providence City Administrative Land Use Authority considered an approval request for a conditional use of an in-home salon by Makiah Luther, located at 555 South 75 West. Skarlet Bankhead convened the session and introduced the members present, including Max Pierce (City Engineer), Rob Stapley (Public Works Director).
- The review of the submitted documents, including application, business plan, and site plan, was confirmed. Diane Campbell provided an overview of the relevant city codes and standards. The staff report outlined conditions for the applicant to operate in compliance with city, county, and state requirements and to acquire a business license.
- Makiah Luther described the salon operation from the home basement, detailing the nature of services provided, which are limited to nails and haircuts without acrylic or other services requiring special ventilation. Luther explained their goal to work from home and previous experience running a similar operation.
- Luther's business plan includes scheduling to ensure the presence of only one client at a time and adherence to parking and safety regulations. Following a brief discussion about business operations and potential future changes, the Authority moved to take a vote on the request.

- 46 • The Authority reviewed the approval request by Katelyn Eyster for an in-home dog grooming
- 47 business proposed at 579 South 300 East (correcting the mistaken "West" designation from
- 48 South 300 West). The committee confirmed receipt of necessary documents, including the
- 49 application, business plan, and an overview of city codes applicable to the home business.
- 50 • Diane Campbell presented the findings of facts and conclusions of law, setting out conditions
- 51 adhering to local, state, and county regulations.
- 52 • Mrs. Eyster discussed the planned business operations, including grooming dogs exclusively and
- 53 observing numerous safety measures, notably a choke collar system during appointments.
- 54 • Parking details and waste management plans were recounted, along with criteria for parking
- 55 during snow seasons to comply with local regulations.
- 56 • Mrs. Eyster's grooming schedule anticipates the service of no more than 2 dogs per day for safety
- 57 and to prevent noise. After a comprehensive discussion addressing safety, waste management,
- 58 and client scheduling, the meeting attendees moved to vote on Mrs. Eyster's request.
